

**MINUTES**

August 9, 2010  
North Town Hall

Mayor Jeffcoat called the regular meeting of Council to order at 6:00 p.m. Present were Council members Drew, Jones, Lane and Washington. Also in attendance were Chief Mark Fallaw and Town Clerk Carrie Garrett.

Mayor Jeffcoat led council and visitors in the Pledge of Allegiance.

Mayor Jeffcoat declared a quorum and welcomed visitors.

Councilman Jones made a motion to approve the minutes, as amended, from the July 12, 2010 meeting, seconded by Councilwoman Lane, and upon vote minutes were approved.

Water/Sewer Report:  
Mr. Jeffcoat presented the water / sewer report for July, 2010 (copy attached).

Police Report:  
Chief Fallaw reviewed the North Police report (copy attached). Deputy Steve Thompson from Orangeburg County Sheriff's Office introduced himself. He has been assigned to the Western Region of the county and is looking forward to working with local law enforcement.

Old Business:

- o Jeffcoat reviewed the financial statement for July, 2010.

New Business:

- o Jeffcoat discussed that the Community of Character Trait for August is Cooperation.

Mayor's Report:

- o Mayor Jeffcoat announced that our town auditors had been with us this month and are working on completion of our 2009-2010 audit. Jeffcoat mentioned that the auditor informed him that several other towns recoup the \$5,000 DHEC fee by charging each water bill approximately 65¢ per month. That is an option to generate revenue.
- o Mayor Jeffcoat also announced that he and Councilman Jones attended the MASC Annual Meeting in Charleston.

Public Comments:

- o Eric McMichael made a request for the Town to approve the 5k race scheduled for August 14<sup>th</sup>. After discussion regarding the route, the 5k organization paying for law enforcement coverage (since they are not non-profit), more advance notice next time, a motion was made by Councilman Jones to approve the request to hold the 5k race on August 14<sup>th</sup> in the town limits of North. Motion was seconded and carried. The 5k will start behind the North Town Hall and end behind the North Post Office where they will have winner/trophy presentations.

There being no further business, Councilwoman Lane made a motion to adjourn the meeting. The motion was seconded and meeting was adjourned at 7:00 p.m. Reverend Wright closed the meeting in prayer.

The next Council meeting will be held on Monday, September 13, 2010 at 6:00 p.m.
