

**MINUTES**

North Town Hall

Mayor Jeffcoat called the regular meeting of Council to order at 7:00 p.m. and declared a quorum. Present were Council members Drew, Lane and Gleaton. Councilwoman Binyard was unable to attend due to illness. Also in attendance were Mark Fallaw, Chief of Police, and Carrie Windham, Town Clerk.

Mayor Jeffcoat led council and visitors in the Pledge of Allegiance.

Mayor Jeffcoat welcomed visitors.

Councilwoman Lane made a motion to approve the minutes from the December 8, 2008 meeting, seconded by Councilman Gleaton, and upon vote minutes were approved.

Water/Sewer Report:

Steele did mention to council that it is time to address the possibility of a marquis sign. Steel also mentioned that there was a misunderstanding regarding his impression of SCE&G. He wanted to clarify that he and the Town have been pleased with SCE&G's work on this project and that SCE&G has not caused any delay.

New Business:

- o Jeffcoat discussed that the Community of Character Trait for January is Cheerfulness.
- o Jeffcoat brought up an issue that was raised at the last meeting: Possible change of the Town Council meeting time. It was agreed that the issue would be discussed at the next meeting.

Mayor's Report:

- o Councilman Drew requested information on Southland Sanitation's failure to pick up as scheduled. Carrie Windham did state that she has been in contact with Southland Sanitation regarding this matter and that they have had a changeover in personnel and are working diligently to rectify the situation. It is not prudent to issue a credit across the board to citizens since each account would have to be manually adjusted which would be very time consuming.
- o Mayor Jeffcoat called on Carrie Windham to discuss the Town's Year-In-Review and Goals for 2009.

Public Comments:

- Joe Gleaton reminded the public of the Bar B Q fundraiser on Saturday, April 18<sup>th</sup> and that more information would be forthcoming.
